Rothschild will request reimbursement from the Debtor only for such expenses as were actually incurred and will return the amount of the estimate not utilized. For expenses incurred during the month of June 2010, a credit of \$2,219.10 has been applied to correct a misallocation of expenses from an unrelated matter that had been requested in a previous fee application.
